## **Arbitration Award Summaries**

No. 06-75 – Award issued January 11, 2007

Claimant: *New Films International* (Licensor) Respondent: *Cine Net Entertainment* (Distributor) <u>Principals at the time Final Award issued:</u> Nesim Hason, President - Claimant; Michele Delerno - Respondent Arbitrator: James W. Coupe, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay Claimant the minimum guarantee pursuant to the Distribution Agreement.

No. 05-93 - Award issued January 15, 2007

Claimant: *Exception Wild Bunch* (Licensor) Respondent: *Falcom Media Group AP* (Distributor) <u>Principals at the time Final Award issued:</u> Unknown Arbitrator: Bruce M. Polichar, Esq.

The Final Award found that Claimant was not entitled to the respective minimum guarantees set forth in the Distribution Agreement because Claimant did not deliver the Pictures to Respondent.

The Partial Award and Supplemental and Final Award found that Respondents breached the Acquisition Agreement relating to a Picture and an option to produce sequels, and that all rights, including the option to produce such sequels, reverted to Claimant. Respondents were ordered to pay all amounts due to Claimant pursuant to the Agreement, provide access to records, and deliver physical elements of the Picture to Claimant.

The Final Award terminated Respondent's rights and Claimant's obligations set forth in the Distribution Agreement and ordered Respondent to pay Claimant the remaining two installments due pursuant to the Agreement, less the present value of the Picture.

The Final Award ordered Respondent to complete production of the Picture for delivery and to pay Claimant the balance due pursuant to the Distribution Agreement.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay Claimant, as Sales Agent for Licensor, the unpaid balance of monies due pursuant to the Deal Memos.

The Final Award ordered Respondent to pay Claimant the monies due pursuant to the Distribution Agreement.

The Final Award found that Respondent breached the Distribution Agreement and that all rights to the Picture reverted to Claimant, except for the rights to territories already sold by Respondent.

The Final Award further ordered Respondent to ensure that all future income received from the exploitation of the Picture by third-party licensees be paid directly to Claimant.
