

## **Arbitration Award Summaries**

No. 10-64 – Award issued on January 19, 2011

Claimant: *Jetstream Pictures, LLC* (Licensor)  
Respondent: *Intandem Pictures Limited* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Sol Rosenthal, Esq.

The Final Award (issued after a prove-up in a default case) terminated the Distribution Agreement.

No. 10-54 – Award issued on February 17, 2011

Claimant: *Nu Image, Inc.* (Licensor)  
Respondent: *WEG Entertainment Pvt. Ltd.* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Gerald Phillips, Esq.

The Final Award (issued after a prove-up in a default case) terminated the Distribution Agreement and ordered Respondent to pay to Claimant the balance due pursuant to the Agreement.

No. 10-75 – Award issued on March 10, 2011

Claimant: *Fintage Magyar Kft.* (Licensor)  
Respondent: *EnterMode* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Roy Rifkin, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantees due pursuant to each of three Distribution Agreements and terminated each Agreement.

No. 10-56 – Award issued on March 15, 2011

Claimant: *American Cinema International, Inc.* (Distributor)  
Respondents: *Izidore Musallam, Hand 'n' Hand Films, Inc. and Savage Planet, Inc.* (Licensors)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Michael Donaldson, Esq.

The Final Award (issued after a prove-up in a default case) found Respondents jointly and severally liable for monies due to Claimant pursuant to the amended Distribution Agreement.

No. 10-91 – Award issued on April 27, 2011

Respondent: *Unikorea* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Stephen Strick, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantee due pursuant to the Deal Memo and to return the Picture and all related materials to Claimant. The Award also terminated the Deal Memo.

No. 07-75 – Award issued May 12, 2011

Claimant/Cross-Respondent: *Comerica Bank* (Lender)  
Respondents/Cross-Claimants: *Gary Howsam, Greenlight Film & Television, Inc., GFT Circle Films, Inc., GFT Road Rage Films, Inc., Janus Productions, Inc., GFT Going Back Films, Inc., GFT Heresy Films, Inc., GFT Redwood KOTN Films, Inc., GFT Redwood/Ignition Films, and Peace Arch Motion Pictures* (Producers)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Stephen S. Strick, Esq.

The Final Award (issued after a prove-up in a default case) found that Respondents breached their respective Loan and Security Agreements with Claimant and were ordered to pay to Claimant the outstanding balance due pursuant to the Agreements. The Award also ordered Respondents to pay Claimant compensatory damages. The cross-complaint filed by Respondents was dismissed with prejudice.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantee due pursuant to the Deal Memo. The Award also terminated the Deal Memo.

Respondent/Counter-Claimant: *Terra Firma Productions, Inc.* (Loanout Corporation)

The Final Award found that Claimants did not provide sufficient evidence to support their claims that Respondent breached the Director Agreement and intentionally and negligently interfered with prospective economic relations. The Award ordered Counter-Respondents to pay Counter-Claimant damages for breach of the Director Agreement.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the installment of the minimum guarantee due upon notice of delivery pursuant to the Distribution Agreement. The Award also terminated the Agreement.

Respondent: *Regent Worldwide, LLC* (Distributor)

Principals at the time Final Award issued: Thomas Becker, Co-Director and Jorg Westerkamp, Co-Director – Claimant; Mark Reinhart, President and CEO -- Respondent

Arbitrator: Jack E. Freedman, Esq.

The Final Award ordered Respondent to pay to Claimant the monies due pursuant to the three Sales Agency Agreements. The Award also terminated the Agreements.

No. 11-60 – Award issued on November 1, 2011

Claimant: *Earthbound Films, LLC* (Licensor)

Respondent: *I Vision Pictures, Co., Ltd.* (Distributor)

Principals at the time Final Award issued: Unknown

Arbitrator: Ronald M. Monitz, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantee due pursuant to the Distribution Agreement. The Award also terminated the Agreement.

No. 11-20 – Award issued on November 2, 2011

Claimant: *Torati Active Film Produktions GmbH & Co. KG* (Licensor)

Respondent: *Rigel USA, Inc.* (Sales Agent)

Cross-Respondents: *Cinefilm Media, LLC and Marina Movie Partners, Ltd.*

Principals at the time Final Award issued: Unknown

Arbitrator: Tony Ballard (licensed attorney in England)

The Final Award ordered the Respondent to pay to Claimant payments due under the Collection Account Management Agreement. The Award also dismissed Respondent's crossclaims without prejudice.

No. 11-71 – Award issued on November 16, 2011

Claimant: *Morgan Creek International, Inc.* (Licensor)

Respondent: *Entermode* (Distributor)

Principals at the time Final Award issued: Unknown

Arbitrator: Paul D. Supnik, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantee due pursuant to the Distribution Agreement. The Award also terminated the Agreement.

No. 11-15 – Award issued on November 28, 2011

Claimant: *Cottonwood Pictures, LLC* (Licensor)  
Respondent: *Icon Film Distribution, Ltd.* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Jack E. Freedman, Esq.

The Final Award ordered Respondent to pay to Claimant the second advance due pursuant to the Distribution Agreement. The Award also terminated the Agreement and dismissed Respondent's counterclaims.

No. 11-25 – Award issued on November 30, 2011

Claimant: *Film & TV House Limited* (Licensor)  
Respondent: *Valentim de Carvalho Multimedia, S.A.* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Martin Perlberger, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantees due pursuant to three Distribution Agreements. The Award also terminated the Agreements.

No. 09-184 – Award issued on December 1, 2011

Claimant: *Newbridge Film Capital LLC* (Licensor)  
Respondent: *cineFinance Insurance Services, LLC for and on behalf of Houston Casualty Company* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Ronald S. Rosen, Esq.

The Final Award found that Claimant was estopped from asserting that Respondent failed to deliver the picture and that its notice of default was effective due to Claimant's inconsistent conduct in attempting to resolve the dispute with the Respondent who defaulted on the Distribution Agreement because Claimant permitted Respondent to edit the Picture after the agreed upon delivery date. All claims for relief were denied.

No. 11-62 – Award issued on December 5, 2011

Claimant: *Freeway Entertainment Kft.* (Licensor)  
Respondent: *Mirovision, Inc.* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Mark Litwak, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the final installment of the minimum guarantee due pursuant to the Distribution Agreement. The Award also terminated the Agreement.

No. 11-33 – Award issued on December 28, 2011

Claimant: *Stiletto Productions, Inc.* (Licensor)

Respondent: *International Film Fund, LLC d/b/a Fabrication Films* (Distributor)

Principals at the time Final Award issued: Unknown

Arbitrator: Henry Silberberg, Esq.

The Final Award ordered Respondent to pay to Claimant the amounts owed pursuant to the Sales Agency Agreement. The Award also found that Respondent breached the Agreement and its fiduciary duties, and further ordered Respondent to provide copies of agreements and documents related to distribution of the Picture. The Award denied Respondent's counterclaims and terminated the Agreement.
