

### **Arbitration Award Summaries**

(Listed in chronological order of the date of issuance of the Final Award)

No. 15-55 – Award issued on January 12, 2016

Claimant: *Dandelion Holdings, LLC* (Licensor)  
Respondent: *MGN Films, Inc.* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Eve Wagner, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the balance of the minimum guarantee due under the Distribution Agreement, and the Agreement was terminated. Pursuant to cross breach termination clauses, a second Distribution Agreement, which was not in default, was also terminated.

No. 15-32 – Award issued on March 9, 2016

Claimant: *Vermillion Productions, LLC* (Licensor)  
Respondent: *MGN Films, Inc.* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Hillary S. Bibicoff, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the balance of the minimum guarantee due under the Distribution Agreement, and the Agreement was terminated.

No. 15-54 – Award issued on March 24, 2016

Claimant: *Hannibal Classics, Inc.* (Licensor)  
Respondent: *MovieOn Pictures & Entertainment Ltd.* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Louise Nemschoff, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantee due under the Distribution Agreement, and all rights under the Agreement were terminated.

No. 15-07 – Award issued on June 16, 2016

Claimant: *Illirios Consultants Limited, LLC* (Licensor)  
Respondent: *Societatea Română de Televiziune* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Michael L. Novicoff, Esq.

The Final Award found that a Deal Memorandum between the parties was unenforceable because the signatory could not bind the Respondent. However, Respondent was ordered to pay Claimant the value of concessions it made to Respondent for other fully executed Agreements.

No. 16-09 – Award issued on June 17, 2016

Respondent: *Joy N Contents* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Flip Petillion (licensed attorney in Belgium)

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantee installments due under the Distribution Agreement.

No. 16-04 – Award issued on July 20, 2016

Claimant: *QED Films Sales, LLC as agent for Kasbah, LLC* (Licensor)  
Respondent: *Top Film Distribution, LLP* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Michael C. Donaldson, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the balance of the minimum guarantee due under the Distribution Agreement, and the Agreement was terminated.

No. 16-14 – Award issued on August 26, 2016

Claimant: *National Bank of Canada* (Licensor)  
Respondent: *EnterMode Corp.* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Mark Litwak, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantee due under the Distribution Agreement, and the Agreement was terminated.

No. 16-26 – Award issued on August 31, 2016

Respondent: *Apex Success Global Ltd.* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Richard Marks, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the remaining installments of the minimum guarantee due under the Distribution Agreement.

No. 16-31 – Award issued on October 18, 2016

Claimant: *Hannibal Classics, Inc.* (Licensor)  
Respondent: *Rafaella Films International* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Sol Rosenthal, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the final installment of the minimum guarantee due under the Distribution Agreement, and the Agreement was terminated.

No. 16-27 – Award issued on December 13, 2016

Claimant: *Comerica Bank* (Licensor)  
Respondent: *MGN Films* (Distributor)  
Intervenor: *Film Finances, Inc.* (Guarantor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Michael R. Blaha, Esq.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantee due under the Notice of Assignment. The Award also found that Intervenor provided Notice of Delivery of the Picture to Respondent in accordance with the Assignment.
